(3) Paragraph First of the Certificate of Incorporation of MAJOR LEAGUE BASEBALL PROMOTION CORPORATION, which . sets forth the name of the corporation is hereby amended to read: nom-mes sees of the corporation is MATOR LEAGUE BASEBALL PROPERTIES, INC. (4) Paragraph Second of the Certificate of Incorporation of MAJOR LEAGUE BASEBALL PROMOTION CORPORATION, which sets forth the purposes of the corporation is hereby amended to read: SECOND: The objects and purposes for which the Corporation is formed are to do any and all of the things hereinafter set forth, to the same extent as natural persons might or could do in any part of the world, to wit: a. To obtain from The National League of Professional Baseball Clubs and its member clubs and from The American League of Professional Baseball Clubs and its member clubs the right to use, on their behalf, and to authorize and license others to use their names; emblems; logotypes;

pictures of teams, personnel and facilities; uniform and other designs; insignia; symbols; devices; traditional colors; coats of arms; mascots; slogans; and other identifying symbols. b. To use and to authorize and license others to use films and videotapes of major league professional baseball games and excerpts therefrom. c. To publish or arrange for the publication of books, magazines, newspapers, newsletters, programs, pamphlets, stati tics or other written materials. d. To take any and all other actions to promote, advertise and publicize major league professional baseball. e. To have, in furtherance of the corporate purposes, all of the powers conferred upon corporations organized under the Business Corporation Law subject to any limitations thereof in the laws of the State of New York. (5) These amendments to the certificate of incorporation. of MAJOR LEAGUE BASEBALL PROMOTION CORPORATION were authorized by a vote of the board of directors followed by the affirmative vote of the holders of a majority of all outstanding shares entitled to vote thereon at a meeting of the shareholders duly called and held on the 4th day of November, 1987, a quorum being present.
